# S.A.R.T. Meeting Minutes

Monday, September 18h, 2023

#### 1. Welcome

#### 2. School Assessment Review Team (SART)

Mrs. Kismet explained the purpose of SART. She shared that the goal is share information and gather input from our parents and teachers. She explained that the school site holds 4 meetings per year, 2 per area, and 2 as a district. Mrs. Kismet explained that site administration takes one parent to each area and district meeting. She encouraged parents to email her if they would like to attend the area and/or site meeting. Mrs. Kismet stated that participating in these meetings is a great way to be informed.

#### 3. Status of School

Mrs. Kismet shared that the school year has opened successfully. She highlighted the two new hires in 3<sup>rd</sup> and 4<sup>th</sup> grade. She stated that students have settle in well, were excited to be back, and school culture is positive. Mrs. Kismet highlighted that our teaching teams have been collaborating to make instructional plans for the year to create the best educational experiences for students.

#### 4. 22-23 State Assessment Results

Mrs. Kismet shared a Powerpoint data presentation with our overall school performance, Clovis West area school data, and similar school rankings. She highlighted that we went down slightly in ELA and up in Math. She discussed the school's SED (socio-economically disadvantage population) and that we are outperforming like schools and schools with a lower SED. Additionally Mrs. Kismet provided demographic data on ELA and Math performance.

- a. Math
  - i. CUSD 52% to 55%
  - ii. Maple Creek 60% to 65%
- b. ELA
  - i. CUSD 60% to 61%
  - ii. Maple Creek 72% to 69%

#### 5. School Safety

Mrs. Kismet provided information regarding school safety. She informed parents that the system they began using last year across the district is called Catapult which is an automated emergency system. She let parents know that doors continue to be locked and that we continue to train students to not open the door. Additionally, she highlighted that the school conducts at least monthly safety drills and while we do safety drills we practice using Catapult to account for all adults and staff on campus.

# 6. ASB funds-Thank you for supporting our fundraiser!

Mrs. Kismet highlighted the conclusion of our ASB fundraiser which brought in \$26,000. She explained the types of purchases that can be made with ASB and highlighted the prior year purchases to give examples. Mrs. Kismet also mentioned that the expectation with ASB fundraising is that it benefits the students that raised it directly. She thanked parents for the generous support.

#### 7. All For Youth

Mrs. Kismet shared about the County Services All For Youth. She highlighted the programs beginning to service all families. She highlighted that in the beginning All For Youth provided services to all families regardless of insurance status, however within the first year of servicing at Maple Creek they realized the demand in Fresno County was greater and they revised services to those who are insured by Medical. Mrs. Kismet shared the brochure and that they can be a service to any families and connect them to various agencies and services.
